Wavy is made from robust steel sheets. The construction allows for easy disassembly and replacement of parts in case of damage or maintenance. Wavy's dimensions are optimized for resource-efficient and environmentally-friendly transportation.

Overview

- The modules are made from 20% recycled robust steel with long durability.
- Circular product: the modules can be disassembled and replaced, refreshed, repaired, renovated, and recycled.
- The steel body is made of parts that are joined with screws and can be separated when renovation is needed.
- Inner containers, combined with a raised base, allow for the use of paper bags.
- The inner containers and raised base are made from 100% recycled plastic.

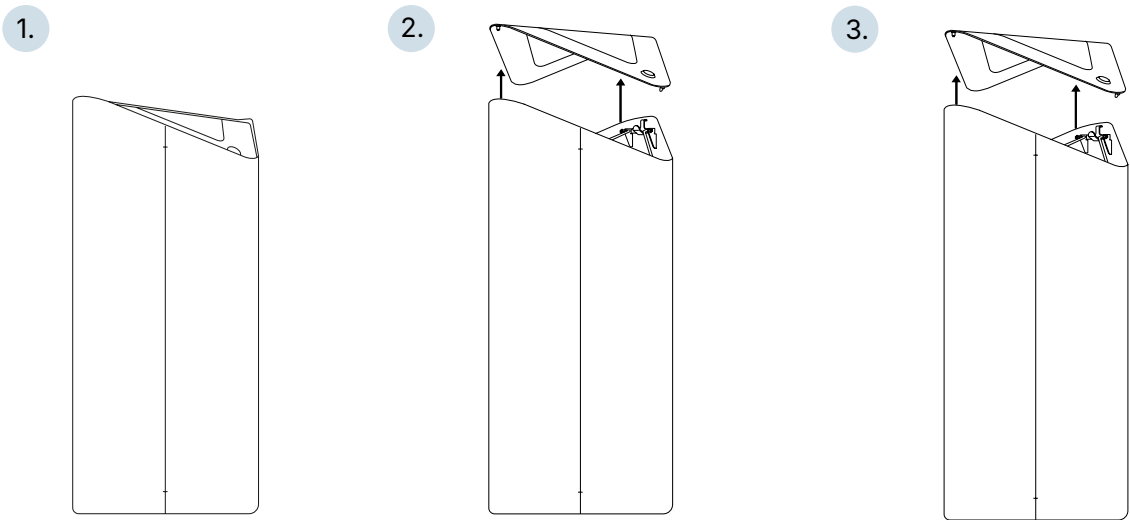

Stackable container with handle.
Base insert is used as bottom insert in the container. The perforations allow airflow, reducing moisture buildup.
Add the base insert when using food waste bags as they often have a lower depth.

Change of rubbish bag

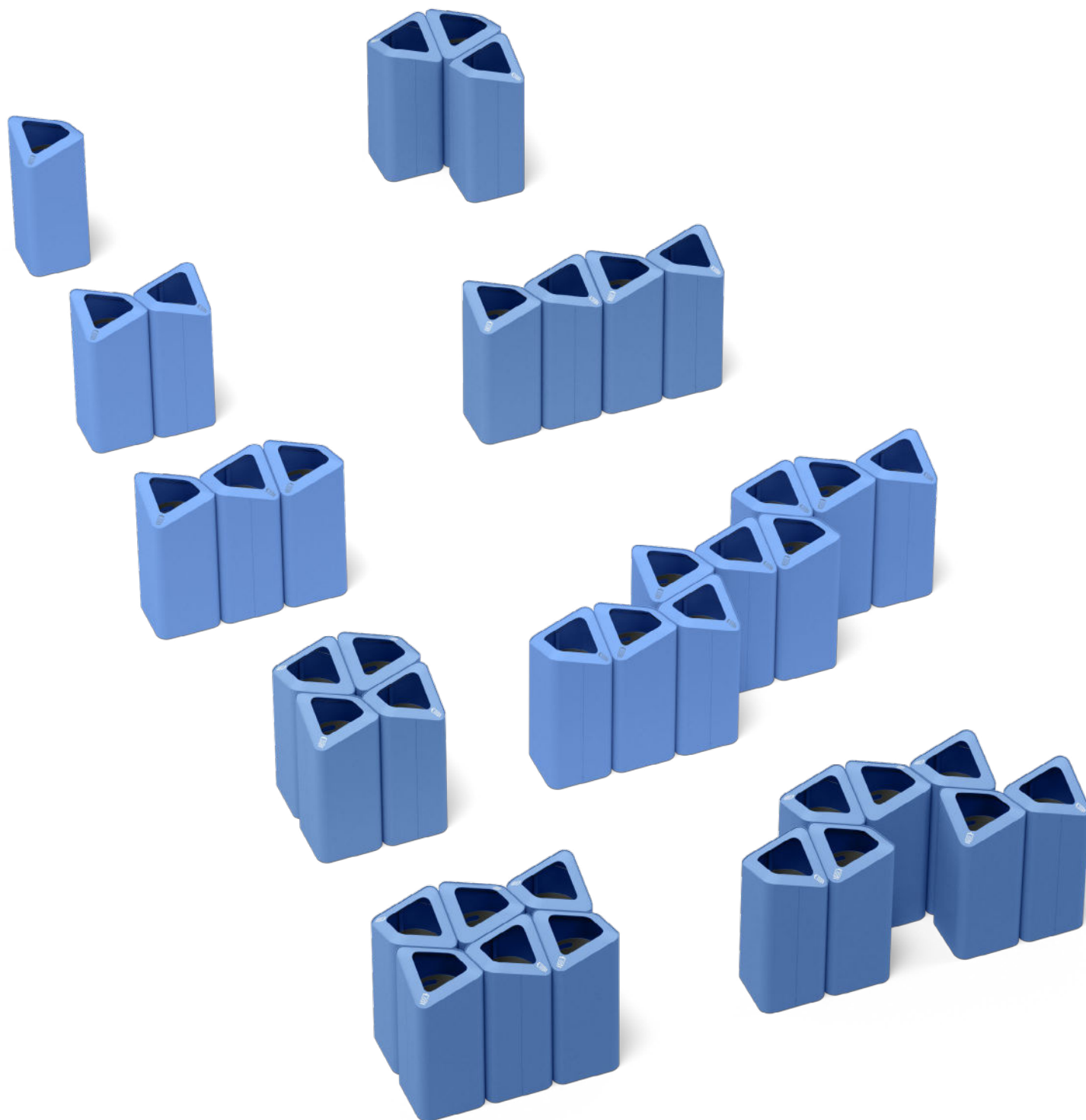


Wavy frame with lid.

Lift up the lid. Lids with locks need to be unlocked before lifting.

Remove the rubbish bag from the bag holder and lift it up to facilitate emptying. If there is a risk of leakage, use inner containers.

Metal

Circularity

Product information, warranty and circularity

***Warranty:** The warranty is valid from the date of delivery of the product. Invoice/order number must be quoted for the warranty to be valid. The warranty does not apply to products that have been stored or assembled incorrectly, used in an inappropriate or improper manner, altered in appearance/function or cleaned with an incorrect cleaning method or cleaning products. The warranty does not cover damage in transit, normal wear and tear, scratches, marks or damage caused by impact or accident. The warranty does not apply if the product has been placed outdoors or in a humid environment, or if the product has been used for purposes other than those for which it is intended.

For products intended for outdoor use, the aforementioned humid environment does not apply, but the warranty period is halved for installation within 200 metres of a coastal environment. The warranty does not apply to outdoor products where surface corrosion occurs over time as this is purely aesthetic and can be remedied with touch-up paint.

General care instructions

Metal

Wipe with a slightly damp, soft lint-free cloth and mild detergent. Always wipe dry with a dry cloth. Never use solvents on painted metal or abrasive materials.
